**PLAINTIFFS' MOTION FOR
ATTORNEYS' FEES, COSTS, AND SERVICE AWARDS**

Plaintiffs Mark Boswell, David Lutton, and Vickie Snyder, on behalf of the certified class, respectfully move for class counsel's attorneys' fees and expenses pursuant to Federal Rule of Civil Procedure 23, and for service awards for the three class representatives. This motion is supported by affidavits of counsel, exhibits detailing costs and expenses in this class action, as well as a supporting brief.

Class counsel respectfully request that this Court grant:

1. Attorney fees in the amount of \$1,575,427, representing 33% of the total judgment amount, to be allocated between class counsel as follows: \$551,399 to Popham Law Firm (35% of attorneys' fees awarded), and \$1,024,028 to Coffield PLC (65% of attorneys' fees awarded);
2. Reimbursement of litigation expenses in the amount of \$35,745.86, to be paid to class counsel out of the total judgment amount, and allocated between class counsel as follows: \$12,955.48 to Popham Law Firm and \$22,790.38 to Coffield PLC;

3. Class representative payments to Mark Boswell, David Lutton, and Vickie Snyder in the amount of \$50,000 each, for serving as the class representatives in this action, to be paid out of the total judgment amount.
